Board of Governors, BITS Pilani, 76th Meeting

Date: 11th September, 2023

1. Welcome Address:

• The Chancellor welcomed members and highlighted progress in research, startups, internationalization, and alumni funding.

2. Key Approvals:

- Appointment of Prof. V. Ramgopal Rao as Vice Chancellor (effective 10 March 2023).
- Renewal of Shri Akshay Poddar's membership on the Board of Governors.
- Revision of Faculty Superannuation Policy (extension up to 70 years).
- Extension of Prof. G Sundar's term as Director, Off Campus Programs and Hyderabad Campus.
- Appointment of faculty members in administrative roles.
- Revision of scholarships for Dubai Campus students.
- Increase in tuition fees for AY 2023-24 and enhancement of Ph.D. fellowships.
- Constitution of committees for Distinguished Alumnus Award, Distinguished Services Award, and BITS Ratna Award.
- Rationalization of fees for Ph.D. students.

3. Achievements:

- Rs. 55 Cr in external research grants.
- 195 PhDs graduated (highest ever).
- 574 companies participated in placements with an average salary of Rs. 20.8 LPA.
- Alumni funding reached Rs. 32 Cr, with a significant pledge of Rs. 15 Cr by Rakesh Verma.

- Appointment of Prof. Soumyo Mukherji as Director, Hyderabad Campus (effective 1st January 2024).
- Pre-placement offers for BITSoM students from top companies.
- Progress on BITSoM's permanent campus in Kalyan, set to open in early 2024.

3. Key Approvals:

- Appointment of Dr. Saravanan Kesavan as Dean of BITSoM.
- Establishment of BITS Design School at the Mumbai Off-Campus Centre.
- Constitution of a sub-committee for the Design School to handle approvals, land acquisition, and other formalities.

General Achievements Across 2023:

- Admissions: Increased BITSAT applications and higher cut-offs.
- **Infrastructure**: Expansion projects completed across campuses, including a dedicated startup facility.
- **Alumni Engagement**: Largest-ever funding of Rs. 32 Cr and scholarships benefiting 115 students.
- **BITSOM**: Strong placement outcomes and leadership transition.
- **BITS Law School**: Successful launch with 120 students and 75% women in the founding cohort.

Minutes of General Body Meeting

Minutes of the 62nd Meeting of the General Body of BITS Pilani

Date: 11th September 2023

1. Welcome Address

- Dr. Kumar Mangalam Birla welcomed the members and expressed gratitude for their presence.
- He highlighted the substantial progress made by BITS Pilani in research, startups, internationalization, and alumni funding, emphasizing the institution's commitment to growth and excellence.

2. Key Updates and Discussions

2.1 Admissions

- Indian Campuses: 3254 First Degree (FD) students admitted in 2023 (vs. ~3000 normal batch size).
- **Dubai Campus:** 329 FD admissions in Semester 1.
- **BITSAT:** Conducted twice, resulting in 1.23 lakh unique applications and 1.93 lakh total applications (7% increase over last year). Cut-offs increased by 3%-8%.

2.2 Faculty Recruitment

- 118 offers made in AY 2022-23.
- 424 faculty members joined in the last five academic years.

2.3 Research

- Rs. 55 Cr external grants received in FY23.
- 195 PhDs graduated in AY 2022-23 (highest ever).
- Current PhD enrollment: 1826 (22% CAGR over 5 years).
- 221 patents filed to date; 41 granted. Target: 100+ patents/year in 2024.

2.4 Student Placement

- 574 unique companies participated in AY 2022-23 (vs. 540 in AY 2021-22).
- Average salary: Rs. 20.8 lakhs (13% increase, comparable to top 5 IITs).
- Summer internship program gaining traction.

2.5 Physical Infrastructure

- Expansion projects completed across Indian campuses.
- Pilani Incubation & Innovation Centre to be inaugurated next month.
- Renovation of hostels, mess, and academic blocks completed at Pilani.
- New faculty housing completed at Goa.
- Hyderabad expansion fully completed.

2.6 Alumni Relations

- Alumni database: 66,200 on AlmaConnect.
- Largest-ever alumni funding: Rs. 32 Cr in FY23 (~Rs. 80 Cr in 5 years).
- Rakesh Verma pledged Rs. 15 Cr for Pilani Convention Centre.
- Scholarships benefiting 115 students across campuses.

2.7 BITSoM (BITS School of Management)

- First batch graduated in 2023 with a mean compensation of Rs. 23.85 lakhs.
- Top recruiters: McKinsey, Bain, EY, JP Morgan, etc.
- Third batch admitted with 154 students (45% gender ratio).
- Permanent campus at Kalyan nearing completion.

2.8 BITS Law School

- Established in March 2023 in Mumbai; approved by the Bar Council of India.
- First academic year started on 1st August 2023 with BA LL.B. (Hons.) and BBA LL.B. (Hons.) programs.
- Interim campus in Powai; permanent campus in Kalyan by 2025.
- Advisory Council includes eminent legal and academic professionals.
